Spread stripping solution liberally over the floor and let stand from 10 - 20 minutes. Do not allow the solution to dry on the floor.

Scrub thoroughly with a floor machine to break up the softened film. Pick up the dirty solution with a shop vac or auto scrubber. Detail mop the floor with clean water to remove all residue. Let the clean floor dry completely before refinishing.
